

OFFICIAL RULES FOR QUICK DRAW 50% BONUS HOURS – SELECT RETAILERS
Effective April 2024
UPDATED: April 2, 2024

The New Jersey Lottery is conducting a Quick Draw 50% Bonus Hours promotion (“Quick Draw Bonus Hours Promotion”) at select Retailers whereby players who purchase Quick Draw on a single Quick Draw ticket between the hours noted in the Promotional Period below are eligible for a chance at 50% increased prizes. To the extent you access the Quick Draw Bonus Hours Promotion on the New Jersey Lottery mobile application through an Apple device, please be advised that the Quick Draw Bonus Hours Promotion is not associated with, sponsored, endorsed or administered by Apple.

1. The Promotion Period for the Quick Draw Bonus Hours Promotion is defined as follows:

- The Quick Draw Bonus Hours Promotion is offered at select New Jersey Lottery licensed retail locations listed as “Active” in the New Jersey Lottery’s Gaming System. A complete list of select New Jersey Lottery licensed retail locations will be posted in these Official Rules and updated as necessary throughout the Promotion Period. The New Jersey Lottery reserves the right to add or remove New Jersey Lottery licensed retail locations to this list throughout the Promotion Period.
- Players must be 18 years or older to play and participate in the Quick Draw Bonus Hours Promotion. Persons prohibited from purchasing New Jersey Lottery tickets or shares pursuant to N.J.A.C. 5:9-16 and N.J.A.C. 17:20-1.3 are prohibited from playing or participating in the Quick Draw Bonus Hours Promotion.
- Players (sometimes referred to as “you” or “your” or “players”) who purchase Quick Draw on a single Quick Draw ticket at select New Jersey Lottery licensed retail locations during the Promotion Period, are eligible for a chance at 50% increased prizes subject to these Official Rules. Eligible purchases may or may not include the Quick Draw game add-ons, BULLSEYE or Multiplier.
- New Jersey Lottery Quick Draw tickets generated by the New Jersey Lottery’s Gaming system that are eligible for the Quick Draw Bonus Hours Promotion will contain the following ticket message printed on the ticket as shown below:

6. The New Jersey Lottery may declare any Quick Draw ticket purchased during the Promotion Period void if it is damaged or stolen.
7. The New Jersey Lottery reserves the right to adjust, make exceptions for and disqualify select New Jersey Lottery licensed retailers from participating in the Quick Draw Bonus Hours Promotion at any time during the Promotion Period as deemed necessary by the New Jersey Lottery, in its discretion, to ensure the integrity of the Quick Draw Bonus Hours Promotion and/or when such action is determined by the New Jersey Lottery, in its discretion, to be in the best interest of the New Jersey Lottery.
8. The New Jersey Lottery reserves the right, without prior notice, to cancel, terminate, modify or suspend the Quick Draw Bonus Hours Promotion at any time and for any reason, including but not limited to if the New Jersey Lottery determines that a virus, bug, unauthorized human intervention, fraud or other cause beyond its control has or is corrupting or affecting the administration, security, fairness or proper conduct of the Quick Draw Bonus Hours Promotion.
9. By participating in the Quick Draw Bonus Hours Promotion, you agree to forever waive, discharge, indemnify and release the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, commissioners, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC (collectively "Affiliates"), from any and all liability, injury, damage, death, litigation, claim, cause of action or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with your participation in the Quick Draw Bonus Hours Promotion, your acceptance, possession, use or misuse of any prize awarded in connection with the Quick Draw Bonus Hours Promotion, any defect with the Quick Draw Bonus Hours Promotion, and/or any error in the administration or operation of the Quick Draw Bonus Hours Promotion. You, on behalf of yourself and/or your spouse, heirs, executors, administrators, representatives, successors, assigns and next of kin, waive all claims for damages, injuries and/or death, whether known or unknown, and whether caused by negligence or not, sustained to you or your property that you may have against the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective Affiliates arising out of or associated with your participation in the Quick Draw Bonus Hours Promotion, your acceptance, possession, use or misuse of any prize awarded in connection with the Quick Draw Bonus Hours Promotion, any defect with the Quick Draw Bonus Hours Promotion, and/or any error in the administration or operation of the Quick Draw Bonus Hours Promotion.

10. Pursuant to the New Jersey Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1 et seq.), holders of winning New Jersey Lottery tickets or shares may choose to remain anonymous indefinitely. The identity of a holder choosing to remain anonymous shall not be included under materials available for public inspection pursuant to the New Jersey Open Public Records Act (N.J.S.A. 47:1A-1 et seq. and N.J.A.C. 17:20-7.7). Holders of winning tickets or shares may expressly authorize use by or on behalf of the New Jersey Lottery of his or her name, address, prize amount and photographic or videographic likeness, in any medium for the sole purpose of advertising and publicity.
11. By participating in the Quick Draw Bonus Hours Promotion, New Jersey Lottery licensed retailers and Players agree to fully comply with these Official Rules and to accept the decisions of the New Jersey Lottery or its designee as final and binding with regard to the Quick Draw Bonus Hours Promotion.
12. The Quick Draw Bonus Hours Promotion is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.
13. These Official Rules may be changed at any time without prior notice if determined by the New Jersey Lottery or its designee to be in the best interests of the New Jersey Lottery.
14. All winners, tickets, and transactions in connection with the Quick Draw Bonus Hours Promotion are subject to New Jersey Lottery Rules and Regulations and State law. All prizes awarded in connection with the Quick Draw Bonus Hours Promotion are subject to claim procedures, validation tests and other applicable requirements of the New Jersey Lottery. Liability for void or nonconforming ticket, if any, is limited to replacement of ticket with un-played ticket. Neither the New Jersey Lottery nor Northstar New Jersey Lottery Group, LLC is responsible for lost or stolen tickets. The Quick Draw Bonus Hours Promotion is void where otherwise prohibited by law. This Quick Draw Bonus Hours Promotion is not valid in combination with any other New Jersey Lottery promotion or coupon.
15. Winners are solely responsible for payment of all applicable federal, State and local taxes associated with any prize awarded in connection with the Quick Draw Bonus Hours Promotion.
16. Odds vary based on amount of numbers played; for detailed information see Odds and Prizes at NJLottery.com/QuickDraw.
17. The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision of these Official Rules. In the event that any provision of these Official Rules is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The failure to enforce any provision of these Official Rules will not constitute a waiver of that or any other provision of these Official Rules.

18. Subject to New Jersey Lottery Rules, “Official Game Rules Quick Draw” (Effective October 29, 2020) and “Addendum Official Game Rules Quick Draw Game Rules Bullseye” (Effective October 29, 2020), and “Addendum Official Game Rules Quick Draw Game Rules Multiplier” (Effective March 1, 2022) a prize amount won in connection with the Quick Draw 50% Bonus Hours Promotion may be pari-mutuel. The combined prize liability shall be limited to \$3,000,000, per drawing, when playing any 10-spot with or without the add-ons game features. If the combination of the amount of match 10 of 10 winners along with their prize values (including the add-on game features) exceeds \$3,000,000, the prize division shall be parimutuel.
